## **Additional Notes:-**

### **Mopeds, Motorcycles and Scooters**

- A Road Tax** - New tax rates introduced from June 1999
- B Insurance** - Average rates for a Third Party Fire & Theft policy. No allowance has been made for a no claims discount.
- C Depreciation** - due to the recent reduction in many of the new motorcycle prices it is impossible to fully assess depreciation within the scope of this leaflet. The amount of depreciation will depend on the actual purchase price paid and can only be accurately assessed by the individual owner at the time of sale.
- D Helmet/Clothing** - Allowance is made for the purchase of helmet and protective clothing and assuming a service life of 3 years.
- E AA Membership Subscription**
- F Petrol** - Based on the average price of a litre of petrol at the time of publication. The cost per mile figure is calculated from what we consider to be a reasonable fuel consumption for the various engine capacity groups.
- G Engine Oil** - Allowance is made for normal oil consumption and routine oil changes.
- H Tyres** - Service life is adjusted according to the type of motorcycle, but this will also vary depending on the individual riding style.
- I Servicing** - Routine servicing as recommended by the manufacturer.
- J Repairs and Replacements** - An allowance is made for routine repairs and replacements which are likely to be needed due to normal wear and tear. However it is unrealistic for us to allow for any major repairs, which will only occur as a result of unexpected mechanical or electrical failures. For this reason only the owner of the motorcycle can assess the true cost of this item, as repair costs will vary, even when comparing identical models.
