

# Terms and Conditions for the AA Member Tukker Toy Free Prize Draw

## 1. The Free Prize Draw

- 1.1 These terms and conditions apply to the daily free prize draw for AA Members, where the AA will give away Tukker Toys via our social media pages, across 7 consecutive days. We'll give these away within the official AA accounts on Facebook and Instagram:

- 1.2 Up to 600 individual Tukker Toys (Prize) are available across the 7 consecutive days of the free prize draw, starting at 00:01 on 8 July 2021 and ending at 23:59 on 15 July 2021.

- 1.3 Prizes are subject to availability

- 1.4 Please note, Tukker Toys aren't suitable for children under 36 months.

## 2. Promoter's name and address

- 2.1 The promoter of the free prize draw is Automobile Association Development Limited of Fanum House, Basing View, Basingstoke, Hampshire, RG21 4EA ("the AA").

## 3. How to participate in the Free Prize Draw

- 3.1 To enter the free prize draw go to <https://www.facebook.com/TheAAUK/> or [https://www.instagram.com/theaa\\_uk/](https://www.instagram.com/theaa_uk/). Please note, comments posted outside of these AA accounts won't be counted as entries.

- 3.2 All entries require the participant to comment on the post within the comments box as per the details in the caption on social media. It's down to the AA's discretion whether we accept comments that don't completely adhere to the required details.

- 3.3. You may only enter the free prize draw a maximum of once per day across all platforms.

- 3.4 No purchase or payment is necessary to enter the free prize draw or to win.

- 3.5 By entering this free prize draw you accept these terms and conditions.

## 4. Eligibility

- 4.1 The free prize draw is only open to residents of the UK **aged 18 or over and have an active AA roadside breakdown policy and are an active AA breakdown Member (AA Membership doesn't include AA Cars, Home and Travel Insurance customers).**

- 4.2 The following aren't eligible to enter or win this free prize draw:

4.2.1. employees of the AA or its holding subsidiary companies;

4.2.2 employees of agents or suppliers of the AA or its holding companies, who are professionally connected with the competition or its administration; and

4.2.3 members of the immediate families (including their spouses, biological, adoptive or stepparents, legal guardians, children, siblings, or grandparents, any legal dependents and household members) of those identified in 4.2.1 and 4.2.2 above.

- 4.3 In entering the free prize draw, you confirm that you're eligible to do so and eligible to claim the prize or any prize you may win. The AA may require you to provide proof.

- 4.4 Entries not in accordance with the terms and conditions won't be counted and will be excluded.

- 4.5 Entries which are received after the closing date and time, incomplete, misspelt, inappropriate, inaudible, or incomprehensible, aren't acceptable and won't be entered into this free prize draw.

- 4.6 Only one Tukker Toy will be issued per person under this offer, irrespective of the number of times entered.

## 5. Selection of the winners

- 5.1 The winners will be selected at random from all eligible entries by an automated process.
- 5.2 The winners will be notified by **direct message on the relevant social media channel they used to enter** within **24 hours** of the closing date of the free prize draw and will be asked to provide their full requested details.
- 5.3 The winners will have until 23:59 on Sunday 18 July 2021 to respond to the direct message with the requested details (for direct Members this will be their membership number, postal address, full name and email. For bank customers, this will be their surname, email and postal address) to claim the prize. For direct Members and bank customers who are unable to provide their full requested details by 23:59 on Sunday 18 July 2021, it'll be at the AA's discretion to decide whether we provide the prize.
- 5.4 A third party (such as a relative of the Member) can enter the competition on behalf of the Member, but the prize will be sent to the Member's address.
- 5.5 The AA doesn't accept any responsibility if you're not able to claim the prize.
- 5.6 The prize will be sent to the winners within 30 days of being notified of their win. The AA isn't responsible for prizes that aren't received, but where relevant the AA will try to get a replacement Tukker Toy issued depending on evidence of non-delivery.
- 5.7 The prize is awarded conditionally upon acceptance and if a winner can't to be contacted after **48 hours**, or if any prize is unclaimed or declined within **48 hours**, the prize will be deemed unclaimed or unaccepted and another winner may be drawn at the AA's discretion.
- 5.8 The AA retains the right to substitute the prize with another prize of similar value in the event the original prize isn't available.
- 5.9 The prize isn't negotiable or transferable for any other product or service or a cash alternative.
- 5.10 The decision of the AA is final. No correspondence will be entered into regarding the outcome.

## 6. Limitation of liability

- 6.1 In so far as is permitted by law, the AA, its agent or distributors won't in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize, except where it's caused by the negligence of the promoter, its agents, or distributors, or that of their employees. Your statutory rights aren't affected.
- 6.2 You understand that this prize draw promotion is in no way sponsored, endorsed, administered by or associated with Facebook and you hereby provide a complete release to Facebook of any responsibility for this prize draw.

## 7. Data protection and publicity

- 7.1 The winner may be asked to take part in future publicity.
- 7.2 The AA will use your personal data for the purpose of the management of the free prize draw, including to assess your eligibility for the free prize draw and to administer the competition.
- 7.3 The AA must either publish or make available information that indicates that a valid award took place. The AA are required to make the forename, surname and a country of the winner available upon request. To comply with this obligation, the AA will send the surname and country of major prize winners to anyone who contacts us or writes to the AA, Fanum House, Basing View, Basingstoke, RG21 4EA – to Group Marketing (enclosing a self-addressed envelope) within 1 month after the closing date stated in condition 5 above.
- 7.4 If you object to any or all of your surname, country and winning entry being published or made available, please contact the AA at <https://www.theaa.com/help-support/contact-us>, or through our social media channels. In such circumstances, the AA must still provide the information and winning entry to the Advertising Standards Authority on request.
- 7.5 Your personal data will be retained in accordance with the AA's Privacy Notice – available at <https://www.theaa.com/privacy-notice> – which explains what happens to any personal data that you give or any that the AA may collect from or about you.

**8. General**

- 8.1 If there's any reason to believe that there's been a breach of these terms and conditions, the AA may, at its sole discretion, reserve the right to exclude you from participating in the free prize draw.
- 8.2 The AA reserves the right to hold void, suspend, cancel or amend the prize draw where it's become necessary to do so.
- 8.3 These terms and conditions (and any issues or disputes arising) shall be governed by English Law, and The AA and entrants to the prize draw submit to the exclusive jurisdiction of the English courts.
- 8.4 The AA would respectfully request that any Tukker Toys won aren't sold online.
- 8.5 Customers who are entitled to AA Breakdown cover as a benefit of their bank account are eligible to enter the Member competition.
