## What is the type of insurance?

A cash payment of up to £100,000 if you're seriously injured or die following an accident in the car under this policy.



#### What is insured?

- Provides a cash payment for a range of bodily injuries including, but not limited to, the following:
  - Accidental death £100,000
  - Loss of limb(s), eye(s), hearing or speech – £100,000
  - Fractured bones (a complex break in the full thickness of the bone) up to £1,500
  - Facial scarring £1,500
  - Third Degree burns £7,500
- ✓ £60 Hospital stay and temporarily disabling injury benefit for the first period of hospitalisation of between 6 and 24 hours and for each full day thereafter of hospitalisation or during which a bodily injury prevents working or carrying out daily activities up to a maximum of 180 days
- ✓ Reimbursement of up to £750 for up to 5 Physiotherapy sessions
- Only the policyholder is covered following an accident in the car insured under the AA insured motor policy as well as any other private car
- Named drivers and passengers are covered following an accident in the car insured under this policy



#### What is not insured?

- Injuries sustained in accidents that occurred before the start of the policy
- Injuries sustained in accidents where the injured person is 81 years of age or over
- Injuries sustained in accidents where the driver was under the influence of, or being affected by, alcohol or drugs, other than drugs being taken under the direction of a qualified medical practitioner



#### Are there any restrictions on cover?

- ! The payment in the event of fatality for any passengers under 16 years of age is £7,500
- ! There is no cover for named drivers or passengers when injured in cars other than those cars covered under the AA insured motor policy
- ! The daily hospital cash payment is limited to 180 days



#### Where am I covered?

## What are my obligations?

- · To hold a valid car insurance policy with AAISL to claim on this product

### When and how do I pay?
